Agenda Item 5: Precinct Consolidation

Recommended Action: By Resolution, approve of the request from the Clerk to consolidate the following precincts for the May 7, 2024, Special Election for voters that reside in the New Haven School District:

Precinct 16 Clinton-Macomb Public Library North 54100 Broughton; Precinct 17, Senior Center 51210 Alma; and Precinct 24 Clinton-Macomb Public Library North 54100 Broughton; and

BE IT FURTHER RESOLVED that the Clerk shall notify the affected voters in Precinct 17 that their polling location will change for this election only to Clinton-Macomb Public Library North 54100 Broughton; and

BE IT FURTHER RESOLVED to approve of the request from the Clerk to consolidate the following precincts for the May 7, 2024, Special Election, for voters that reside in the New Haven School District:

Precinct 22 Recreation Center 20699 Macomb Street; and Precinct 23 Recreation Center 20699 Macomb Street.

BE IT FURTHER RESOLVED that the Clerk shall notify the affected voters that their polling location will change for this election only from the above referenced locations to the Clinton-Macomb Public Library North 54100 Broughton.

This approval is being granted in accordance with Michigan Election law MCL 168.659, which authorizes the Election Commission to proceed with precinct consolidation provided a resolution is adopted at least 60 days prior to the election.
